## NSCW 6th Annual Workshop

The 6<sup>th</sup> Annual Northeast Sustainable Communities Workshop was held in Jersey City at the Liberty Science Center on March 5, 2014. Started by a varied, regional group of environmental professionals, its vision is a lively, intense exchange of ideas regarding brownfields, sustainability and community. Keynote Speakers included David Lloyd, Director, USEPA, Office of Brownfield and Land Revitalization and Jeffrey Logan, Executive Deputy Secretary, PA Department of Environmental Protection. They led presentations on how the changes in leadership at their agencies will impact brownfields, redevelopment, sustainability and communities. In addition, experts from various fields led panels on topics ranging from resilience to green energy. Several SWEP members helped to plan the workshop, including Susan Boyle (GEI Consultants), Elizabeth Limbrick (NJIT), Wanda Chin Monahan (SCC Legal), Colleen Kokas (NJDEP) and Elizabeth Barton from the CT Chapter of SWEP. NJSWEP and Philly SWEP cohosted the Networking Cocktail Reception in the Observation Tower in the Liberty Science Center, with many SWEP members in attendance. # **NYC Highline Walking Tour**

In May, NJSWEP participated in a Brownfields Walking Tour of the High Line in New York City. NJSWEP representatives Elizabeth Limbrick (NJIT) Jillian Mooney (Riker Danzig), Stephanie Turkot (Geo-Cleanse), Cristin Mustillo (Sedita Campisano), Sue Boyle (GEI), and Jeanne Litwin (CDM) joined host, The New York City Brownfield Partnership, and sponsor, The Brownfield Coalition of the Northeast, for a special guided tour of the High Line. Most High Line tours focus on the adjacent architecture of the new developments or the landscape architectural and public art features of the park. This tour focused on six ongoing or completed development sites along the park that are being remediated for reuse. Speakers included Dan Walsh, the Director of the NYC Office of Environmental Remediation (OER) whose office was involved with every project along the route; Gary Rozmus of GEI Consultants, who spoke about CSX's decision process to allow the defunct rail line to be used for recreational purposes; and consultants from Langan and AKRF as well as Posillico, the contractor for one of the sites currently being remediated. Hudson Yards, a large mixed used redevelopment and the Whitney Museum's new location at 820 Washington St. were featured on the tour. The tour group of about 65 ended the event at a beer garden under the High Line, near the Standard Hotel.

# NJSWEP MetroNet Breakfast Seminar: Techniques, Tools and Tips for Navigating the Ecological Evaluation and Ecological Risk Assessment Process in New Jersey

On November 13th, NJSWEP MetroNet and Langan Engineering & Environmental Services, Inc. hosted a breakfast seminar at Langan's offices in Elmwood Park, New Jersey. After a hot breakfast and networking, more than 25 NJSWEP members and guests listened to a presentation given by Elisa Buckley and KariAnne Czajkowski of Langan who reviewed the ecological evaluation/risk assessment process and provided insight into the techniques and tools to help understand and strategize effective approaches to meet the technical requirements of the State. Topics covered included: an overview of the Ecological Evaluation (EE) Regulatory Process; Study Design Considerations; and the when, where and how's of Ecological Risk Assessment (ERA). Ms. Czajkowski, who serves on the Ecological Evaluation Technical Guidance (EETG) Committee, also gave an update on Potential Changes to the EETG that will occur in the near future.
